Installing Casino Deluxe

- 1) Insert the Casino Deluxe CD into your CD-ROM drive.

for **Windows 95** users:

- 2) *If the Autoplay feature is enabled, a panel will automatically appear on your screen.*
- 3) *If Autoplay is not active, double click on the My Computer icon on your desk top and click on the CD-ROM drive (usually D) to access the panel.*

for **Windows 3.1** users:

- 2) *From the Program Manager, select **Run** from the File menu.*
- 3) *In the box that appears, type the letter of your CD-ROM drive, followed by a colon, then \SETUPEXE and press the <Enter> key on your keyboard. For example, if your CD-ROM drive is your D drive, you would type D:\SETUPEXE and press <Enter>.*
- 4) Follow the onscreen instructions. During the installation, you will be given two options: you may either install the entire game to your hard drive, or you may install only part of the game, the rest being accessed from the CD as you play. If you install the entire game ("Hard Disk Copy"), it will take up about 30 megabytes of

space on your hard drive. If you install part of the game ("CD resident"), the installed portion will take up about 4 megabytes of space. *If you choose partial installation, make sure the game CD is in your CD-ROM drive whenever you play the game or view the strategy supplements.* Full installation may result in faster gameplay.

Once you enter the game, you will see an introductory sequence. Click your mouse if you would like to skip through the screens. The computer will ask you if you would like to begin a new game or load a saved game. If this is your first time at Casino Deluxe, select **New**. If you would like to continue a previously saved game, select **Load**, and choose your saved game from the box that appears.

You will then find yourself in the lobby of Casino Deluxe. To begin, click on the elevator doors (or select **Go To Elevator** from the menu bar), and then select the button for the game you wish to play (or select **Choose Game** from the menu bar). To exit Casino Deluxe from the lobby, click on the glass doors (or select **Exit Casino Deluxe** from the *File* menu).

For general game instructions, select **How to Play** from the *Help* menu in the lobby. Consult the *Help* menu in each game for specific instructions.

To save a game, select **Save Game** from the *File* menu, and type a name for your game in the box that appears. Make sure your game has an extension of ".sav" (example: **mygame.sav**).
