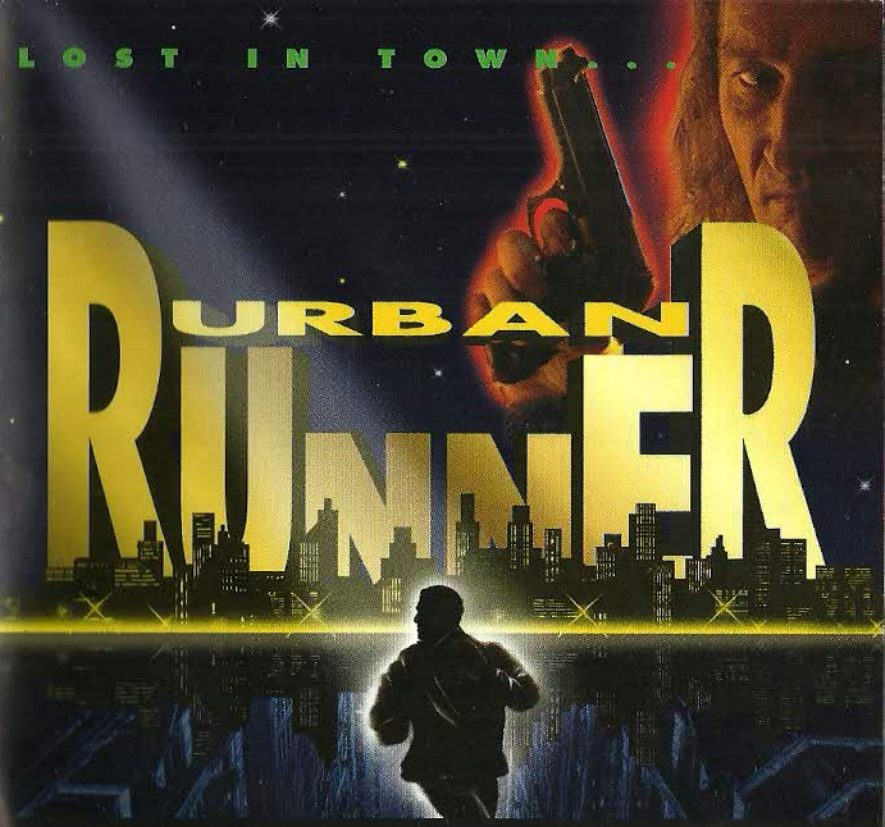

Installation

Installation in Windows 3.1

1. Insert *Urban Runner* CD No. 1 into your CD drive.
2. Start Windows.
3. Click on File.
4. Select Run.
5. On the command line, type the letter corresponding to your CD drive, then SETUP.EXE. Click on Ok or press Enter. For example, if your CD drive is drive D, type D:\SETUP.EXE, click on OK or press Enter.
6. Follow the on-screen instructions.
7. Once the game is installed, you may be asked if you would like to scan the READ-ME file. This file contains the latest information from the most recent game tests. We highly recommend reading it.

Starting *Urban Runner* in Windows 3.1

1. Insert CD No. 1 into the CD-ROM drive.
2. Start Windows.
3. Double click on the game icon in the Sierra folder.

Installation in Windows 95

1. Start Windows 95.
2. Insert *Urban Runner* CD No. 1 into your CD-ROM drive.
3. If the game has not yet been installed, you will be asked if you wish to do so. To install, a Windows 95 box appears on the screen with two options: "Install" and "Cancel". Click on "Install" to install *Urban Runner*.
4. Follow the on-screen instructions.

Starting *Urban Runner* in Windows 95

1. Start Windows 95.
2. Insert (or reinsert) *Urban Runner* CD No. 1, 2, 3 or 4, depending on where you are in the game, into the CD-ROM drive. A Windows 95 box will appear on the screen with two options: "Start" and "Cancel". Click on "Start" to start or pick up where you left off.
